OUR SERVICES

LEGAL ADVICE CLINICS Volunteer Attorneys provide legal advice to clinic clients on a specific legal issue. These clinics are held Thursday evenings and Saturday mornings (*except for major holidays*) and are **by appointment only**.

BRIEF SERVICES Designed to help clients who attend a Legal Advice Clinic and need additional help understanding and completing court forms.

DO-IT-YOURSELF WORKSHOPS Volunteer Legal assists self-represented individuals in filing for an **Uncontested Divorce**; and **Uncontested Guardianship of a Minor**.

REFERRAL TO PRO BONO ATTORNEYS Clinic clients may be referred to Volunteer Legal's Pro Bono Referral Program if a case is deemed complex. Volunteer Legal will make every effort to place a case with a volunteer attorney who is willing and able to provide direct representation. Services are dependent on the availability of volunteer attorneys. This program **does not** guarantee legal representation.

SERVICE ELIGIBILITY AND FEES

Volunteer Legal offers services to those whose household incomes are at or below 250% of the Federal Poverty Level for the State of Hawaii. Please call Intake at **528-7046** to qualify for services.

FEES

Volunteer Legal charges an administrative fee for its services to help defray program costs. Fees are based on household incomes.
